Minute 198 (2011/12) Apologies for Absence

Apologies were accepted from Councillor Holt. It was agreed that Councillor Arfan would be Chairman for the meeting.

Minute 199 (2011/12) Public Participation

New Development - Griffin Lane

It is anticipated that a planning application to build new properties in the field off Griffin Lane will be sent to Solihull MBC in the near future, since some preparation work has already taken place. Solihull MBC is likely to reject this planning application on the basis that it is premature to the emerging Local Plan (which has a longer timescale for the development), but it may well be approved on appeal. Once the Local Plan is approved, the timescales for development will be fixed, but currently they are not. The Parish Councillors agreed that they were opposed to the early development of this site – it would be unsustainable given the infrastructure of the village, and the village centre needs to be completed first.

Minute 200 (2011/12) Jubilee Committee

The Jubilee Committee are concentrating on getting the health and safety paperwork done, and seeking sponsorship and advertising in the jubilee programme and on their banners. The event will be publicized and the programmes delivered in advance. The Parish Council again thanked the committee for all of their hard work.

Minute 201 (2011/12) Gardening Club

The contractor is ready to deliver the planters which are to replace the barrier at the entrance to the village, but we are still waiting for fire service approval.

Minute 203 (2011/12) To Receive a Report from the Borough Councillors

Councillor McCarthy suggested that the Environmental Champions could arrange for the tatty boarding around Garden Squares to be repainted. The Parish Council have written to BNP Paribas, who are responsible for the boarding, to request permission.

The squareabouts are very expensive to repair, Councillor McCarthy suggested that the Parish Council should be pushing Solihull MBC to look at different options for their repair.

The waste area by the car park behind Tescos was also discussed – Solihull MBC has the power to take this over and finish it. Councillor McCarthy agreed to look into this.
