Minutes of the Meeting of the Council held on Tuesday September 10th 2024

Centrick

Representatives from Centrick joined us at the meeting, following the Parish Council meeting about planning the previous evening, to clarify things and ask our opinion on ideas for Main Street going forward. They advised that Main Street was originally designed to be pedestrianised, not for cars. Main Street is falling into disrepair as it wasn't designed to be used the way it is. It is still currently maintained by Dickens Heath Management Company who need to make some decisions on what to do, especially with potential new developments in the area. It isn't fair to be left to the Dickens Heath Management Company leaseholders. They may need to decide to close it in some way in order to prevent it being used as a rat run, they may decide to use something to obstruct the middle to stop vehicles passing. Centrick are in talks with Solihull Council, there are problems with manholes and other background issues of this kind so they need to take action now. The directors are in agreement that something needs to be done. Centrick need to communicate with the residents of Dickens Heath. The current options are to 1- block off the road, near the new gym on Main Street, with planters which will stop any through traffic, this could be something moveable so that it can still be accessed when necessary and it would be pedestrian only or 2- close the road completely, so there would be no vehicular access, just pedestrian. There are concerns around loss of parking. They will be asking the leaseholders for their opinions but wanted to approach the Parish Council and residents to give the opportunity for engagement and ideas, they are open to suggestions. Residents that are present agree that it is a good idea, one suggests that there are bollards that go up and down to allow access Borough Councillor Ken Hawkins speaks about the issues they are experiencing on Main Street, he has done some research and there are other areas in the same situation. Solihull Council's legal position is that the management company should go to The Crown estates but the Borough Councillors appreciate that there is a moral issue, unfortunately it has to go through the usual legal processes.

Centrick discuss the state that the highway on Main Street is in and that there may be more issues that are unknown at the moment. Some of the original documentation has been lost when the area went into administration.

Councillor Richard Small asked about the practicalities of closing part of the road and how people who enter the area can turn around to get out again if the road is blocked off. He discussed the idea of spaces being lost and the difference in closing the entire road. He advised that the Parish Council aren't against the idea but that it needs some more development. He asked Centrick to write to the Clerk with the different options outlined with details on the turning points.

There was a discussion around the cost of repairing Main Street. Centrick have previously had quotes in the region of sixty thousand pounds for the drain work etc and seventy thousand for everything. They are happy to share this information with the Parish Council. There may be more problems discovered when work gets underway. Andy from Centick will email us with the information. A resident suggested that there may be a covenant on the road that states there must be a highway. Jean advises that they need to go back to the original section 106 agreements, she has seen them when looking into a different matter. Planning Issue

A resident raised an ongoing issue with a property in the village where the owner has built an extension without correct permissions, Jean advised that Solihull Council Planning will be writing to the resident.

Braggs Farm Lane

A resident is concerned about the 'Road Closed' signs on Braggs Farm Lane and wondered if anyone knew why they were still there when the work has finished. The Parish Council wasn't aware of the reason for this but will keep an eye on it.

Minutes

At the last meeting a resident raised an issue that he feels there was a mistake in previous minutes where Ken Hawkins stated that Main Street is with The Crown. The Clerk checked this and the minutes are correct to what was said in the meeting, although the information given needs to be checked. This has now been clarified by Centrick at this meeting. Waterside Car Park.

A resident raised some issues they have been having in the Waterside car park with it being flooded and waterlogged so that he cannot access his car in the way that he needs to. Centrick updated that they have installed a pump to get rid of the water which has worked. They have had a structural engineer out to try to work out what the problem is which is proving to be quite difficult. They are working on it but for now, the pump will keep the water down

For issues such as this, Andy from Centrick advised that he is always in the management office on Tuesdays between 10am and 4pm so that residents can go and see him.

Local Plan Update

Borough Councillor Ken Hawkins spoke about the Local Plan update, he feels the upshot of this is 2000 homes in the area. The focus has to be on local infrastructure and the BL1 Sports Facilities. He feels that the Dog Kennel Lane development is slightly different. There may be more developments coming along. We haven't had the usual flash flooding this summer which may be down to key areas being cleared more often. The area near the bungalow that floods has a culvert near it which can't cope when heavy rain comes. That means that Cheswick Green also floods. More balancing ponds are needed in new developments. Budgets

Solihull Council has to think of ways to save money, they have a big problem. One idea is to cut waste collection and have it fortnightly, they will be introducing food collection which has to be in place by 2026.

BL1 South

It is all about the relocation of the sports pitches and infrastructure requirements. Jean Walters requested that Ken speak to Borough Councillor Richard Holt about the event that the Parish Council held in the Village Hall last night about the developments. She has been studying the NPPF framework. She feels that the old Local Plan didn't work and this gives us a chance to produce a new Local Plan that does work and she is willing to give her time to help write it. Borough Councillor Ken Hawkins feels we need the sites in the new plan. Jean feels she has a lot of evidence to get rid of the 2000 homes affiliated with Birmingham. Borough Councillor Keith Green offered his apologies for missing last nights meeting.

We need to get clarification on whether this is term time only. The Parish Council are really pleased to be able to provide this for the older children in the village in collaboration with Solihull Council. Winner sport is an accredited provider and has a youth worker.
