Minute 39 (2025/26) Apologies for Absence

Persimmon Development

A resident spoke about his ongoing concerns around the Persimmon development and the plan to put the apartments across from the bungalows. Councillor Taylor reassured him that we are doing everything we can to help and get them to relocate the apartments.

Minute 42 (2025/26) To Receive a Report from the Borough Councillors

Minute 43 (2025/26) To Receive an update from the Planning Advisory Group about Site BL1

Councillor Taylor updated that they had a meeting with Persimmon and delivered the message about the apartments discussed above. Planning adviser Jean Walters has a plan to form a green buffer around Tidbury Green and Dickens Heath. The Green belt consultation has been received by Solihull Council and they will be looking at it.

Minute 44 (2025/26) Minutes of the Meeting of the Council held on June 10th 2025 Councillor Vicky Taylor proposed, and Maureen Holloway seconded, all in favour, the minutes are approved.

Minute 45 (2025/26) Parish Council Decisions

Bramble Bees Use of Village Green – we are awaiting more information on this. No decision can be made at this time.

Minute 46 (2025/26) Finance and Risk Committee

Councillor Taylor updates. Finance and Risk Training plan and Dignity at Work Policy are due to be signed off at the next meeting of Finance and Risk Committee. The Clerk to be the Data Protection Officer, will need to undertake training annually. All Councillors agree to this.

Minute 47 (2025/26) Communications and Events Committee

Councillor Small updates, he suggested a WhatsApp group just for sharing holiday dates for all Councillors and staff so that we can be more aware of when people will be away to keep things running smoothly. There has been a response from the Crown about our email, it said they haven't got the information yet.

<u>Library</u>

Councillors Small and Halford had a meeting with Kate Bunting about the Library which they felt went well. They are recruiting for a new member of staff. The Librarians have been giving out the QR code to complain about the closures of the Library, we have been promoting this as well and Solihull Council have had over thirty complaints already. Nothing is allowed to be stored in the server room. Councillor Small has been in contact with Solihull Council about holding some language classes in the Library to support our non English speaking residents. CCTV

Village Hall

Councillor Taylor would like to go to a Village Hall meeting as they have shown an interest in working more closely with the Parish Council. Councillor Woodus updates that the Village Hall has had quite a few issues with people not leaving the premises how they found it.

12 Brockhurst Lane, this tree is not on their land, this has been reported to the tree officer. 14 Brixfield Way, this is all ok, within permitted development.
